

## Affiliation document

**The aims of the Association are as follows:**

1. to promote Re-Visionary memb, its philosophy, and its spiritual, ecological and ethical values;
2. to infuse all areas of society with the values held by Re-Visionary Art so as to work towards the raising of human consciousness and thereby contribute to global transition;
3. to found a network of worldwide interdisciplinary artistic connections aspiring to co-create this new society.

### **Benefits offered by the Re-Visionary Art Group**

In order to attain its objectives, the Group offers the following services to its Members:

- presentation of affiliated artists (active Members only) on its website in order to make known their works and their artistic approach;
- the production of a free online magazine;
- opportunities for regular get-togethers for discussion, sharing of ideas, joining up on projects, collaboration, and mutual stimulation. Meetings may be held for one body of artists or several bodies together;
- varied activities carried out in full-day meetings with workshops, guided meditations followed by group creation, and other themes;
- occasional training sessions in the arts;
- promotion of the Members' works through exhibits, concerts, theatrical productions, publications, and public lectures.

## Description of the different categories of Members

### Active Members

Is eligible for active Membership any artist interested in the fulfillment of the objectives of the Re-Visionary Art Group, who has first read, conscientiously accepted, and signed the Re-Visionaries' Manifest, and whose file for application has been evaluated and approved by the Executive Committee, according to the criteria and values mentioned in the Manifest. Active Members must also give signed agreement to the regulation for Authorization to Publish.

Active Members have the right to vote.

### "Butterfly" Members

The term 'Butterfly' Member applies to all active Members who are either students, retired or invalid. A certificate attesting such status is required.

'Butterfly' Members have the right to vote.

### Associate Members

Any individual interested in helping the Association work towards its aims may become an Associate Member. An associate Member does not have to be an artist and need not sign the Manifest.

Associate Members vote in an advisory capacity only.

### Patrons

Any individual person or legal entity may become a Patron of the Association. This category concerns any persons particularly desiring to support the Group financially. Patrons need not be artists; nor do they have to sign the Manifest.

Patrons vote in an advisory capacity only.

### "Inflorescence" Members

Any legal entity, such as local authorities, institutions, associations, and businesses, committed to supporting the aims of the Association may become an 'Inflorescence' Member.

The 'Inflorescence' Member designates a person to represent it in the Association.

Only one individual person at a time may participate in the activities of the Association on behalf of the 'Inflorescence' Member, who is free to designate different individuals for different activities. "Inflorescence" Members need not be artists; nor do they have to sign the Manifest.

'Inflorescence' Members vote in an advisory capacity only.

## Affiliation with the Re-Visionary Art Group

Persons wishing to become Associate Members, patrons, or “inflorescence” Members are asked simply to fill out the Membership registration form.

### Application file for Active and “Butterfly” Members

If you are an artist and recognize yourself in the Values listed in the Re-Visionary Group’s Manifest and/or wish to conform to them, you are eligible to become an Active or “butterfly” Member of the Group. We ask you firstly to read, consciously accept, and sign the Re-Visionary Manifest, and send it together with your Membership registration form via e-mail to [art-re-visionnaire@protonmail.com](mailto:art-re-visionnaire@protonmail.com) .

Please attach a file containing:

1. a good quality portrait photo of yourself
2. a short biography (about half an A4 page)
3. a description of your artistic approach (about half an A4 page)
4. a list of your exhibits, concerts, publications, etc.
5. **a:** for works in the visual arts, high quality (well exposed, sharp and clear, not dark) pictures in 300 dpi (EPS or JPG);  
**b:** for musical works, a web link enabling us to hear and perhaps see the work;  
**c:** for film or theatrical works, a web link enabling us to see them;  
**d:** for literary works, a summary of the book with enough information to get an idea of the book
6. the addresses or websites and social networks where your work is presented (if such exist)

The works submitted for admission evaluation remain your property.

### Annual fees:

- Active Member:	CHF	108.-
- ‘Butterfly’ Member (retired, invalid, student):	CHF	72.-
- Associate Member:	CHF	30.-
- Collective or ‘inflorescence’ Member:	CHF	300.-
- Patron:	CHF	150.-

### Registration Fees:
